**Waiver and Release**

**I, the undersigned, agree that the activities offered by this playing field are at my own risk and that I sign this waiver and release knowing that I give up any right to compensation or legal action if I am injured or suffer loss.**

**I understand that:**

1. The activities are physically and mentally intense, and that serious injury to myself or others may occur.
2. The activities can be dangerous if not played in accordance with the stated rules of which I have been instructed, understood and will abide by. I will ask if I am not sure.
3. The activities take place on rough and uneven grounds, and North Shore Paintball and the property owners do not provide any assurance that the grounds are safe. I promise to be responsible for moving carefully on all grounds, and moving only at a speed such that I can take all necessary care.
4. That other patrons may engage in conduct that is dangerous to me, and the operators cannot supervise the behavior of others, and I accept the risk that others may cause me harm deliberately or accidentally.
5. That I am fully responsible for my own safety, and do not rely upon the operators or the owners to protect me from others or from my own use of the grounds.
6. That the equipment used in the activity can cause injury, and is potentially dangerous, and I do not rely on the operators or owners to ensure any equipment I use is safe, or to instruct me or others in its use.
7. That the Squamish Nation is not the operator of this site, and I accept that they exercise no oversight and have no liability for any activity on-site.

I hereby release and forever discharge from any claims of liabilities whatsoever without limitations that I might have against North Shore Paintball, the Squamish Nation, Chief and Council, and any other operator or their personnel, hereafter called the Sponsors & Property Owners, indemnifying them against any and all claims, procedures, costs, expenses (including legal fees and expenses), damages and liabilities arising out of, connected with, or resulting from playing the Game including, without limitation, those resulting from the manufacture, selection, delivery, possession, use, or operation of such equipment. I hereby release the Sponsors & Property Owners from any and all such liability, and I understand that this release shall be binding upon my estate, my heirs, my representatives and assigns. I hereby certify that I am in good health and do not suffer from a heart condition or other ailments which could be aggravated by exertion involved in playing the game.

I further confirm that I have specific insurance to cover any injuries that I may sustain or cause to others and that I have read and fully understood the terms of this agreement. I agree to rely upon my own insurance for any harm that may occur.

**This is fully intended to be a legally binding contract. If I have any doubts concerning any aspect of its' content, I will not play until I obtain legal advice. I certify that I am at least 18 years of age and in good health and intend to be bound by this agreement.**
